SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020, SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021 and SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022 (collectively referred to as "Circulars"). As per the above circulars, Companies are allowed to hold AGM through VCOAVM without the physical presence of Members at a common venue.

In compliance with the above circulars, the Notice of the AGM along with Annual Report for FY 2021-22 will be sent to all Members in electronic mode, whose email ID's are registered with the Depository Participant(s) ("DP")/Registrar and Share Transfer Agent ("RTA") of the Company.

The Notice of the AGM along with Annual Report for FY 2021-22 will also be made available on the Company's website at www.sonata-software.com and websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com respectively and also on the website of NSDL www.evoting.nsdl.com.

Members holding shares in physical mode are requested to furnish their email ID's with the Company's RTA, KFin Technologies Limited (formerly known as KFin Technologies Private Limited), at inward.ris@kfinfintech.com and Members holding shares in dematerialized mode, are requested to register their email IDs and mobile numbers with their relevant depositories through their depository participants.

The instructions for attending the AGM through VCOAVM will be provided in the Notice of the AGM.

The Company is providing remote e-voting facility to all its Members to cast their votes on all resolutions set out in the Notice of the AGM. Additionally, the Company will be providing the facility of voting through e-voting system during the AGM. Detailed procedure for remote e-voting and e-voting is provided in the Notice to the AGM.

Shareholders may note that the Board of Directors in their meeting held on April 29, 2022 have recommended a final dividend of ₹ 13/- per share. The record date/book closure for the purpose of final dividend for fiscal year 2022 is Thursday, June 16, 2022. The Register of Members of the Company will be closed from June 17, 2022 to June 23, 2022 (both days inclusive). The final dividend, once approved by the Shareholders in the ensuring AGM will be paid on or after July 1, 2022, electronically through various online transfer modes to those shareholders who have updated their bank account details. For shareholders who have not updated their bank account details, dividend warrants/demand drafts/cheques will be sent to their registered address. To avoid delay in receiving the dividend, Shareholders are requested to update their KYC with their depositories (where shares are held in dematerialised mode) and with the Company's Registrar and Share Transfer Agent (where shares are held in physical mode) to receive the dividend directly into their bank account.

Shareholders whose shareholding is in electronic mode are requested to notify any change in address or bank account details to their respective depository participant(s). Shareholders whose shareholding is in physical mode are requested to opt for the Electronic Clearing System (ECS) mode to receive dividend on time in line with the Circulars. A Resident Individual Shareholder with PAN and who is not liable to pay income tax can submit a yearly declaration in form No. 15G/15H, to avail the benefit of non-deduction of tax at source by email to inward.ris@kfinfintech.com by June 13, 2022. Shareholders are requested to note that in case their PAN is not registered, the tax will be deducted at a higher rate of 20%.
